

## Brow Henna Tint + Shaping Consent Form

Brow Henna Tint is a natural, conditioning treatment that can promote new brow hair growth over time. The tint stain lasts on the skin 2-14 days and on the hair 4-6 weeks. It is a multi-step treatment that includes mapping/drawing out the brow shape, precise application of the Henna to achieve a crisp line, and a processing time up to 30 minutes. A brow shaping (via waxing, tweezing or threading) is also included with this service.

**NOTE:** All Brow Henna contains Paraphenylenediamine (PPD) . Although rare, there are those who are sensitive or allergic to PPD. You are **required** to schedule and complete a Brow Henna Patch Test & Consultation a minimum of one week prior to your Haus Salon Brow Henna appointment, with the same service provider for both services.

### What to Expect:

- Brows are cleansed to remove any makeup and natural oils
- Desired brow shape is mapped/drawn out
- Henna is precisely applied and allowed to process up to 30 minutes
- Brows are shaped during the drying portion of the henna processing

### If any of the below apply to you, we unfortunately **cannot** perform the Brow Henna Tint + Shaping service on you.

- Younger than 13 years of age: Those 17 years & younger require signed consent from a legal guardian & the guardian must stay on-site for the duration of the service. A sensitivity patch test is REQUIRED to be conducted a minimum of 1 week prior to the service for those 17yrs & younger.
- Allergy or sensitivity to Paraphenylenediamine (PPD)
- Have ever experienced a sensitivity or allergic reaction to hair coloring, brow/ lash tinting or henna tinting
- Received any chemical treatment service on brows (such as Classic Brow Tinting, Brow Lamination, etc) within 2 weeks prior to conducting a Brow Henna Tint + Shaping service:
  - Combining chemical treatments with a natural henna treatment can cause brow hair damage &/or loss of brow hairs.
- No spray tanning 2 weeks prior to your Brow Henna (you can spray tan afterwards, but will need to put a protective balm over the brow area, which can remove some of the skin stain).
- Recent operations around eye, head or face in immediate area
- Skin trauma, swelling, abrasions or an active infection in the treatment area
- Compromised skin barrier conditions such as eczema, dermatitis, rashes or sunburn near treatment area
- Eye disease
- Pregnancy or lactation
- Currently undergoing Chemotherapy treatment or underwent Chemotherapy treatment less than 1 year before today's date.
- Inability to comfortably lay still while on back, in a supine position, with eyes closed for 60 minutes.
- Use of Botox, aesthetic fillers, injectables, and/or laser treatments within 2 weeks before Brow Henna Tint + Shaping service
- Microblading/Shading: Those undergoing Microblading/Shading sessions cannot have Brow Henna Tint + Shaping within 8 weeks before starting their sessions and must wait six weeks after their final Touch Up session before receiving a facial.

### I acknowledge the following:

- I am 13+ years of age. If between the ages of 13-17 years, I will have a legal guardian who will remain on-site for the duration of the service, as well as provide signed consent below
- Photos may be taken before, during and after the Brow Henna Tint + Shaping service and used for education, promotion or advertising purposes.

- The information provided has been explained to me and all my questions have been answered to my satisfaction. I have read the above information, and I give my consent to have the Brow Henna Tint + Shaping service by the staff at HAUS Salon.
- **By signing below, I acknowledge that I have read the above information and give my consent to receive the Brow Henna Tint+Shaping service. I have either scheduled or completed a complementary sensitivity patch test a minimum of 1 week prior to my service appointment date. The sensitivity patch test, which if conducted, may indicate my sensitivity/allergy to the products. I understand the contents of this form and take full responsibility for my actions, thus absolving all other parties of their responsibilities, if any, associated with the supply of the products and services(s).**
