## Hybrid Brow Dye Consent Form

Hybrid Brow Dye is a color treatment for the brows. The dye stain lasts on the skin 2-14 days and on the hair 4-6 weeks. It is a multi-step treatment that includes mapping/drawing out the brow shape, precise application of the Hybrid Dye to achieve a crisp line, and a processing time of up to 20 minutes.

**NOTE:** All Hybrid Brow Dye contains Paraphenylenediamine (PPD). Although rare, there are those who are sensitive or allergic to PPD. You are **required** to schedule and complete a Hybrid Brow Dye Patch Test & Consultation a minimum of one week prior to your Haus Salon Brow Hybrid Brow Dye appointment, with the same service provider for both services.

#### What to Expect:

- Brows are cleansed to remove any makeup and natural oils
- Desired brow shape is mapped/drawn out
- Hybrid Brow Dye is precisely applied and allowed to process up to 20 minutes

### If any of the below apply to you, we unfortunately cannot perform the Hybrid Brow Dye service on you.

- Younger than 13 years of age: Those 17 years & younger require signed consent from a legal guardian & the guardian must stay on-site for the duration of the service.
- Allergy or sensitivity to Paraphenylenadiamine (PPD)
- · Have ever experienced a sensitivity or allergic reaction to hair coloring, brow/ lash tinting or henna tinting
- Recent operations around eye, head or face in immediate area
- Skin trauma, swelling, abrasions or an active infection in the treatment area
- Compromised skin barrier conditions such as eczema, dermatitis, rashes or sunburn near treatment area
- Eye disease
- Pregnancy or lactation
- Active Cancer or currently undergoing Chemotherapy treatment
- Inability to comfortably lay still while on back, in a supine position, with eyes closed for 30-60 minutes.
- Use of Botox, aesthetic fillers, injectables, and/or laser treatments within 2 weeks before Hybrid Brow Dye service
- Microblading/Shading: Those undergoing Microblading/Shading sessions cannot have a Hybrid Brow Dye treatment within 8 weeks before starting their sessions and must wait six weeks after their final Touch Up session before receiving the service.
- Spray Tanning three days pre or post treatment

#### I acknowledge the following:

- I am 13+ years of age. If between the ages of 13-17 years, I will have a legal guardian who will remain on-site for the duration of the service, as well as provide signed consent below.
- I have scheduled or received a complementary Hybrid Brow Dye sensitivity patch test for a minimum of 1 week prior to my scheduled appointment date. I understand that I do not have the option to waive a sensitivity patch test.
- Photos may be taken before, during and after the Hybrid Brow Dye service and used for education, promotion or advertising purposes.
- The information provided has been explained to me and all my questions have been answered to my satisfaction. I have read the above information, and I give my consent to have the Hybrid Brow Dye service by the staff at HAUS Salon.
- By signing below, I acknowledge that I have read the above information and give my consent to receive the Hybrid Brow Dye service. I have either scheduled or completed a complementary sensitivity patch test a minimum of 1 week prior to my service appointment date. The sensitivity patch test, which if conducted, may indicate my sensitivity/allergy to the products. I understand the contents of this form and take full responsibility for my actions, thus absolving all other parties of their responsibilities, if any, associated with the supply of the products and services(s).
